A meeting is planned for the Darwin Conference to discuss the Draft Standards. The National Executive has set February 1987 as the target for all comments to be received. It is planned to then have them presented for ratification at the Biennial Medical Librarians' Conference in September 1987. The ultimate aim is to have these standards accepted by the Australian Council on Hospital Standards as part of the Accreditation Standards for Hospitals.

ANNE HARRISON FUND

Following the resolution passed at the 1985 A.G.M. to examine the possibility of establishing a fund to assist medical librarianship and to promote professional development, the Victorian Group has submitted a proposal to the LAA asking for approval to use the profits from the last conference to establish this fund. The fund is to be known as the Anne Harrison fund.

AWARDS

A letter of recognition has been awarded by the LAA to Elisabeth Gatehouse, Medical Librarian at the Adelaide Children's Hospital. The award is in recognition of Elisabeth's outstanding contribution to medical librarianship in South Australia, particularly her work towards the production of the GRATISSA scheme's union list of medical periodicals in South Australia. The award was presented to Elisabeth at a very pleasant and well-attended dinner held at the Bangkok restaurant, on the 9th April by the S.A. Branch President, Alan Bundy.

Gunela Astbrink, Librarian at the Disability Information Resource Centre in Adelaide has been awarded \$4,000 to investigate library and information services for the disabled in Vancouver, Toronto, Washington D.C., London and Manchester.

NEWS ON UNION LISTS

The New South Wales Group of co-operative libraries known as GRATIS launched their union list on the 2nd May, and their South Australian equivalent known as GRATISSA plans to launch its list shortly. Both lists have been produced with the assistance of the University Co-op Bookshop, and their contribution is gratefully acknowledged.

News from Queensland is that a similar list is proposed there, and the Victorian medical librarians are examining the possibility of establishing a GRATIS-style network there. If the South Australian experience is anything to go by, such schemes and union lists are well worth the effort.

SOUTH AUSTRALIAN CENTRAL MEDICAL LIBRARY

A model of the proposed new Health Sciences Library has been unveiled as part of the University of Adelaide Faculty of Medicine's Centenary celebrations. The building will be funded by an appeal to medical school graduates and to all members of the medical and health professions in South Australia. The proposal is for a five-storey building with surrounding car parking facilities, and construction on a site, possibly in the vicinity of the Royal Adelaide Hospital, is expected to begin early next year.

Meanwhile, Touche Ross Services Pty. Ltd. has been appointed as a consultant to "work out the organisational and administrative arrangements for the Central Medical Library and to consult closely with the University of Adelaide Faculty of Medicine Centenary Committee regarding the funding of accomodation for the library". At present, no final decision has been made about which institutions will participate in this joint venture.

COURSE IN MEDICAL LIBRARIANSHIP

The Graduate School of Librarianship at Monash University is proposing the establishment of either a course or an elective in Medical Librarianship. The School is hoping to offer the course in 1987, and anticipates contacting the Victorian Group for suggestions regarding specific topics and possible lecturers.

TRANSFER OF NURSING EDUCATION

Following the widespread concern evident at the Melbourne Biennial Conference last year over the problems being encountered with the transfer of basic nursing education from hospitals to institutions of tertiary education, and the subsequent motions passed at the A.G.M., a number of developments have occured in this area. The previous National Executive wrote to a wide range of Commonwealth library and educational authorities outlining the issues of concern to medical libraries and urging that appropriate planning be undertaken to overcome such difficulties.

Replies have now been received from virtually all of these bodies. The general tenor of these responses is perhaps best summarised in the letter from an Assistant Commissioner of the Commonwealth Tertiary Education Commission in which he noted the Commonwealth Government's announcement in 1984 to transfer nursing education in a phased manner to C.A.E.s by 1993 and to provide financial assistance to the States to support this transfer. The Assistant Commissioner stated that "the distribution of this recurrent financial assistance to the States between competing priorities, such as libraries and other recurrent expenditure, is a matter for the relevant State authorities". In their reply, AACOBS took the view that there was no reason to believe, on the information before it, that C.A.E.s would not make proper provision for their nursing students and it is as yet too early to assess the impact of the new nurse education courses upon hospital libraries. Probably the most positive answer was from ALCAE, which has listed the issue for consideration at its A.G.M. in Darwin.

It seems clear the transfer of nursing education is regarded as primarily a matter for the State authorities to manage. The Victorian Group, for example, have received favourable responses from the State Joint Interdepartmental Committee for the Transfer of Nurse Education and from the UCLS National Executive, which this year is domiciled in Victoria. The N.S.W Group is conducting a survey amongst hospital libraries to ascertain problems and collect hard data. The S.A. Group is at present approaching State authorities to obtain their views on the issue.

The L.A.A. has now written to the National Section expressing its concern at the situation and offering to take up the question of nursing education on a national basis if the Section is willing to make specific recommendations. The matter has been placed on the agenda for the Section's A.G.M. in Darwin and the National Executive will be looking for future direction, if any is desired at the National level, from the State Groups so as to respond to the offer of assistance by General Council.
