# Australian Science Index - to go the way of the do-do?

There is a lot of concern existing at present since CSIRO announced its decision to cease publication of the "Australian Science Index". Barrie Mitcheson, President of the LAA, has written to the Minister for Science and Technology, Barry Jones, seeking advice as to CSIRO's successor in producing a scientific bibliography in Australia. Ann Forbes and Margaret Findlay (LAA - Victorian Branch Councillors) have also written a letter to Barry Jones, requesting that funds be provided for the continuation of Australian Science Index.

## Joint Australian Information Council

The initial suggestion for this Council was made in March, 1983, on the premise that it would represent a means of bringing together organisations with an interest in the information sector for regular discussion on matters of common concern. Thus the idea of a "Joint Australian Information Council" emerged.

Such a council (if established) would embody a wide range of members, e.g. AACOBS, ASLA, Australian Society of Archivists, National Book Council, Telecom, Australian Society of Accountants, the Institution of Engineers, to name just a few. All in all, a very diverse group! Some suggestions put forward for discussion might include: a national information policy, public/private sector operations for information dissemination, sales tax on computer hardware and software, copyright in relation to audiovisual materials, etc.

Interest would need to be gauged from the named organisations before such a council would be established. Discussion and comments continue to be sought before any decision is made about the support/non-support of such a council. ## Volunteer workers in libraries

How does the LAA view the use of unpaid volunteers in libraries? In times of financial constraint, some employers may seek to maintain library services by using unpaid, voluntary labour. A draft statement prepared on behalf of the LAA by Roy Stall (W.A. general councillor), is currently being circulated for comment by divisions throughout Australia.

The Association opposes, in principle, the concept of voluntary labour which may be used to compensate for the reduction/withdrawal of services caused by redundancies, non-filling of vacant posts or inadequate staffing establishments. The LAA does not wish to condemn those people who have traditionally provided supplementary services on a voluntary basis. It does however, oppose the substitution of established staffing practices with the introduction of voluntary workers.

Some of the reasons to support this view include - voluntary labour substitution would lead to a deterioration in the standard of library service; it would be wasteful of resources and detrimental to the interests of library users. There may also exist a risk to paid employment.
